### **SPEAKER**

Stan Umpleby, Field Representative for the Ohio Municipal League, distributed some reference materials and thanked the group for inviting him to speak. The biggest item under consideration at the state legislature is HB5 to overhaul municipal income tax. The OML has spent a lot of time on this matter meeting with municipal officials and house and senate representatives. While there are a lot of good parts to the measure, there are many parts that are of great concern to municipalities. The OML's stand is that the measure be revenue neutral, which in its current version would not happen. This is very important with all the loss of revenue that the municipalities have already sustained. The bottom line is that this measure is another assault on home rule. Stan urged everyone to have their mayors and council members contact their representatives about this matter. Letting residents know about the potential impacts is also important. Information on it can be found on the OML website. The proponents of this measure have put a lot of money into this on the political level. An analysis was put together by finance people in northeast Ohio that is called the Traffic Light Analysis. It reviews the pros and cons for each item and is an excellent tool. Stan asked that if anyone has any questions or concerns about any legislation, they should contact the OML. President Hennigan thanked Stan for coming to the meeting.
